**OVERVIEW OF INCIDENT**

The above listed accused (Jeremiah Peikert) was arrested and charged with Conspiracy to Commit Murder and Conspiracy to Commit Risk of Injury to Minors on the strength of an active arrest warrant issued out of New London Superior Court. On 05/01/24, Eastern District Major Crime Detectives assigned to Troop E in Montville traveled to Fort Worth Texas, where the accused was being held as a fugitive from justice and awaiting extradition back to Connecticut. Upon their arrival, Detectives placed the accused into custody and escorted him back to Connecticut via airline travel. This arrest follows a lengthy investigation, as well as, the arrest of the accused's brother, Inmate Joshua Peikert, who is currently incarcerated within the CT Department of Correction, and facing the same listed criminal charges. The accused was unable to post the court-set \$500,000 bond and assigned a next day court date of 05/03/24 at New London Superior Court. No individuals were injured in either of the accused's attempted commission of these crimes. Contact CSP PIO for further information.
