CRIMINAL INFORMATION SUMMARY

OVERVIEW OF INCIDENT

On 05/02/24 at 1100 hours the Connecticut State Police Statewide Urban Violence Cooperative Crime Control Task Force, Statewide Narcotics Task Force, the New Haven Police, Bridgeport Police, and Shelton Police executed a search warrant on the person of Quezon A. Jones (DOB 03/24/1998) of New Haven and his vehicle. The warrant execution was based on an Connecticut State Police narcotics investigation that developed information that Quezon A. Jones, who is a convicted felon, was involved in narcotics distribution. As a result of the search detectives seized the following: \$463.00 in US Currency, (1) Glock 9 mm Handgun altered with a converted trigger switch to allow the weapon to fire in full auto and altered serial numbers, (1) extended 30 round magazine with ammunition, approximately 18.2 grams of cocaine, approximately 10.3 grams of fentanyl, an amount of marijuana and drug packaging materials. Quezon A. Jones. was taken into custody and transported to Troop G. He was processed on numerous weapons and narcotics charges and given a court date at GA#23 with a \$1,000,000 bond. He was unable to post bond and was presented to court on 05/03/24.

This investigation is part of the collaborative effort by State Police and Local Law Enforcement agencies to deter the violent criminal activities associated with narcotics and weapons violations.
