CRIMINAL INFORMATION SUMMARY

OVERVIEW OF INCIDENT

On 10/03/2024 at approximately 1330hrs, in the vicinity of 74 Main St. North in the Town of Woodbury, Officer Wright #LC42 initiated a traffic stop on a black Jeep Grand Cherokee (CT AA03955) for various violations. The operator later identified as Tyler Wilmot (DOB 1/11/1993), exited the Jeep and approached Officer Wright's cruiser. Officer Wright exited his cruiser, a physical altercation occurred, and Officer Wright sustained a stab-like injury to his neck. Officer Covello LC44 arrived on-scene a short time later, at which point Wilmot attempted to flee the scene on foot. Officer Covello deployed his taser and took Wilmot into custody. Officer Wright was transported to Waterbury Hospital by Department cruiser. Wilmot was transported to St. Mary's Hospital for evaluation due to Taser deployment, and later released. Wilmot was then transported to Troop L for processing and was charged with §CGS 53a-49/§53a-54a, Criminal Attempt to Commit Murder 1st Degree; §CGS 53a-167c, Assault on a Police Officer; §CGS 53a-59, Assault 1st Degree; §CGS 53a-167a, Interfering with an Officer; §CGS 14-18(a), Failure to display plate(s); §CGS 14-18(c), obstructed plate(s); §CGS 14-36(a)**, Operating a Motor Vehicle without a license (second offense). Wilmot was held on a \$3,000,000 bond set by GA4 States Attorney's Office, and will be presented at GA4 in Waterbury on 10/04/2024 at 1000hrs.
